SRFDCL invites Expression of Interest from the reputed, well-experienced agency, firms, organizations etc. for in-situ installment of fully automatic Sensors with Cloud based computerized data of treated sewage parameters like PH, BOD, COD, DO and SS at various locations of treated sewage outlets from Shankar Bhuvan to Kotarpur area in Phase-1 to Phase-3 of Sabarmati Riverfront Development Project.

Introduction

Under the Implementation of Sabarmati Riverfront Development Project, Lower promenade and Upper promenade are developed on both the banks of Sabarmati River along 11.50 km long stretch. Construction of Phase-2 i.e. from Dafnala to Indira Bridge on East bank and Torrent Power to Indira Bridge on west bank is also in Progress. Construction of Phase-3 from upstream of Indira Bridge to Narmada Canal Syphon is also starting soon. Sewage released through rain water outlets is diverted/will be diverted through a state of art sewage diversion system having simplified operations in auto mode through gravity (by pumping stations/pumping manholes). The river Sabarmati is not Perennial River but water is released from Narmada Main canal through escape structure at Karai village i.e. @ 19.50km upstream of Vasna Barrage. Water will be going to retain through proposed barrage cum Bridge from Torrent Power on West to Camp Sadar bazar on east bank at R.L. 44.00 and at present water is retained due to Vasna Barrage between R.L. 41.00 and R.L. 41.50 and water flows only when the water is released for irrigation purpose into Fatehwadi canal. This will create about 21 km long water body having width of 262m width with average depth @ 3.50 m.

Objective and Scope of Work

- 1. Sewage is treated through various STP's situated as below;
 - Near Shankar Bhuvan on East bank in Phase-1 (25 MLD)
 - Near Dandi Nala i.e. Jalvihar Society on west bank in Phase-1 (60 MLD)
 - Near dafnal Junction on East bank in Phase-2 (25 MLD)
 - Near Bhat Village on West bank in Phase-2 (25 MLD)
 - Downstream of Kotapur water works on East bank in Phase-3 (25 MLD)

SRFDCL invites Expression of Interest from the reputed, well-experienced agency, firms, organizations etc. for in-situ installment of fully automatic Sensors with Cloud based computerized data of treated sewage parameters like PH, BOD, COD, DO and SS at various locations of treated sewage outlets from Shankar Bhuvan to Kotarpur area in Phase-1 to Phase-3 of Sabarmati Riverfront Development Project at above locations.

- 3. The bidder is free to offer / suggest proven technique/strategy to achieve goals etc.

The bidder will have to submit price per unit for such sensor (inclusive of all taxes/GST) showing item wise quantity and rates for each item along with O&M cost for ten years in a separate sealed cover along with this EOI with mark financial bid or request of Proposal however SRFDCL may ask for revised bid based on the required changes while selection procedure to finalize type and design of such sensors.
- 5. Bidders will be short listed based on information submitted as above (1) and /or if required will be invited for the presentation with information mentioned at (1).
- 6. Short listed bidders based on above, may be further invited for presentation. The presentation should include;
 - a. Concept
 - b. Detailed methodology
 - c. Operation and Maintenance
 - d. Scope of services
 - e. Deliverables
 - f. Comparison with other systems/techniques.

- 2. This Expression of Interest invited exclusively for the proposed work. Acceptance or rejection of any Interested Companies / firms is valid for said work only.
- 3. Expression of Interest Documents can be downloaded from the website www.tender.nprocure.com and D.D. of Rs. 5,000/- shall be presented as document & processing fees along with the submission of EOI in favor of Executive Director, SRFDCL. Without which, EOI from the Companies / firms shall be rejected and not be considered for evaluation.
